SUMMARY

Assists in the preparation and serving of quality food to all students at assigned location.

QUALIFICATIONS/REQUIREMENTS

ESSENTIAL JOB DUTIES

- Provides cashier services in the cafeteria during meal serving hours.
- Prepares daily deposit of cash and scans checks from money collected daily.
- Secures revenues collected daily.
- Supervises and directs other cashiers assigned to his/her building.
- Maintains accurate and detailed records relating to student meal accounts for both breakfast and lunch.
- Generates daily cashier reports and accounts for all money collected.
- Generates month end reports and performs federal edit checks when necessary.
- Generates weekly after school snack reports.
- Verifies that all other cashiers in his/her building balance daily.
- Addresses parent calls and concerns.
- Maintains confidential nature of all school related matters.
- Prepares weekly meal charge notices.
- Trains new cashiers when assigned to his/her building location.
- Assists in meal preparations as time allows.
- Wears and maintains uniforms in a neat, clean, appropriate fashion in accordance with child nutrition dress code.
- Maintains a neat and clean work space.
- Attends meetings, professional development and other trainings as required
- Communicates with the students and staff in a friendly and courteous manner.
- Must be able to lift 40 lbs.

WORK ENVIRONMENT
